9090 was reported as "No Authorized Recipient Available";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days

as required under Indiana Code§ 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may,

without a hearing and in her sole discretion, suspend any insurance license held by the licensee in

the event that the licensee fails to remit the list of appointments within ten (10) days of receiving

the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license

number 3625131 is hereby suspended, effective immediately, and will remain suspended until the

Commissioner receives Respondent's list of appointments.
