FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Respondent's resident producer license expires June 30, 2027;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on April 14, 2025, the Commissioner mailed Respondent certified mail article # 9589 0710 5270 1822 3952 58 requesting a list of appointments to Respondent's address of record;

WHEREAS, on or about April 29, 2025, certified mail article # 9589 0710 5270 1822 3952 58 was returned to the Department marked, "Notice left, no authorized recipient available";

WHEREAS, on May 6, 2025 the Commissioner emailed Respondent requesting a list of

appointments to Respondent's email address of record;

WHEREAS, on May 6, 2025, the Commissioner received confirmation that delivery of

Commissioner's email to Respondent was complete;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days

of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days

constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may,

without a hearing and in her sole discretion, suspend any insurance license held by the licensee in

the event that the licensee fails to remit the list of appointments within ten (10) days of receiving

the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's

license is hereby suspended, effective immediately, and will remain suspended until Respondent

submits the list of appointments requested by the Commissioner.
