**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Victor Rio ("Respondent") is a nonresident insurance producer holding license number 4038508 since August 26, 2024;

WHEREAS, Indiana Code §27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on May 29, 2025, the Commissioner mailed Respondent certified mail article # 9589-0710-5270-1591-5817-46 requesting a list of appointments to Respondent's address of record;

WHEREAS, on May 29, 2025, the Commissioner emailed Respondent a request for a list of appointments to Respondent's email address of record with the "Delivery Receipt" option enabled;

WHEREAS, on May 29, 2025, the Department received confirmation that said email was successfully delivered;


WHEREAS, on June 16, 2025, the status for certified mail article # 9589-0710-5270-1591-5817-46 was reported as "Delivered, To Original Sender";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 4038508 is hereby suspended, effective immediately, and will remain suspended until the Commissioner receives Respondent's list of appointments.
