MOTION TO LIFT SUSPENSION ORDER

The Enforcement Division of Indiana Department of Insurance (“Department”), by counsel, Joseph Bossinger, now moves that the Suspension Order issued on January 15, 2026, in this matter be lifted. In support of this request the Department asserts the following:

1. Tatiana Espinosa (“Respondent”) is a nonresident insurance producer holding license number 3950829 since October 16, 2023.
2. On October 9, 2025, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed certified mail article # 9589 0710 5270 1823 1345 42 to Respondent’s mailing address of record requesting a list of appointments.
3. On October 25, 2025, the certified mail article # 9589 0710 5270 1823 1345 42 was returned to the Department marked as, “Return to Sender, Unclaimed, Unable to Forward.”
4. On December 9, 2025, the Commissioner sent email to Respondent’s email address of record requesting a list of appointments.
5. On December 9, 2025, the Commissioner received confirmation that delivery of said email was complete.

6. Respondent failed to provide the requested list of appointments not more than ten (10) days after receiving the Commissioner's request.
7. On January 15, 2026, pursuant to Indiana Code § 27-1-15.6-12(g), the Commissioner issued a Suspension Order suspending Respondent's license number 3950829 until such a time as the Commissioner received Respondent's list of appointments.
8. On February 10, 2026, Respondent sent an email to the Department providing a list of appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and all other relief just and proper upon the premise.


