ADMINISTRATIVE ORDER AND
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Jason Donnelly ("Respondent") of the following Administrative Order:

1. Respondent was issued surplus lines license number 3732737 on October 7, 2021, and nonresident producer license number 3734436 on October 12, 2021 ("Respondent's Licenses").
2. Respondent's Licenses expired on October 31, 2025, while pending review of renewal applications Respondent submitted on October 6, 2025.
3. The Kentucky Department of Insurance levied a civil penalty against Respondent on December 9, 2022, for failing to file an annual surplus lines reconciliation ("2022 Kentucky Administrative Action").

4. The Illinois Department of Insurance suspended Respondent's surplus lines license on July 12, 2023, effective August 11, 2023, for failing to timely file a semi-annual surplus lines tax statement ("2023 Illinois Administrative Action").
5. Respondent failed to timely report the 2022 Kentucky Administrative Action and 2023 Illinois Administrative Action to the Department.
6. Respondent submitted applications to renew Respondent's Licenses on September 5, 2023, and failed to disclose the 2022 Kentucky Administrative Action and 2023 Illinois Administrative Action in both renewal applications.
7. The Kentucky Department of Insurance levied a civil penalty against Respondent on October 26, 2023, for failing to file an annual surplus lines reconciliation ("2023 Kentucky Administrative Action").
8. Respondent failed to timely report the 2023 Kentucky Administrative Action to the Department.
9. Indiana Code § 27-1-15.6-12(b)(1) states, in part, the Commissioner may refuse to renew an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license.
10. Indiana Code § 27-1-15.6-12(b)(2)(A) states, in part, the Commissioner may refuse to renew an insurance producer license for violating an insurance law.
11. Indiana Code § 27-1-15.6-17(a) is an insurance law that states, in part, a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter.

12. Indiana Code § 27-1-15.6-12(b)(9) states, in part, the Commissioner may refuse to renew an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
13. Indiana Code § 27-1-15.6-12(d) provides that when the Commissioner refuses to renew a license, the Commissioner shall notify the licensee, in writing, of the reasons for the nonrenewal. This Order serves as that notice.
14. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
15. This is considered an agency action by the Indiana Department of Insurance. If you choose to appeal this administrative action, please follow the aforementioned instructions. Subsequently, after the Department has received your written request for a hearing, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and you will receive more information from OALP to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **Respondent's nonresident producer license number 3734436 and nonresident surplus lines license number 3732737 shall not be renewed** due to Respondent's failure to timely report administrative actions, failure to disclose administrative actions in a license application, and for having a license suspended in another state.
