MOTION TO LIFT SUSPENSION ORDER

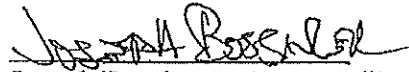
The Enforcement Division of Indiana Department of Insurance ("Department"), by counsel, Joseph Bossinger, now moves that the Suspension Order issued on January 15, 2026, in this matter be lifted. In support of this request the Department asserts the following:

1. Clayton Jean ("Respondent") is a nonresident insurance producer holding license number 3966878 since December 11, 2023.
2. On October 8, 2025, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed certified mail article # 9589 0710 5270 1823 1345 59 to Respondent's mailing address of record requesting a list of appointments.
3. On October 28, 2025, the certified mail article # 9589 0710 5270 1823 1345 59 was returned to the Department marked as, "Return to Sender, Refused, Unable to Forward."
4. On December 24, 2025, the Commissioner sent email to Respondent's email address of record requesting a list of appointments.
5. On December 24, 2025, the Commissioner received confirmation that delivery of said email was complete.

6. Respondent failed to provide the requested list of appointments not more than ten (10) days after receiving the Commissioner's request.
7. On January 15, 2026, pursuant to Indiana Code § 27-1-15.6-12(g), the Commissioner issued a Suspension Order suspending Respondent's license number 3966878 until such a time as the Commissioner received Respondent's list of appointments.
8. On April 6, 2026, Respondent sent an email to the Department providing a list of appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and all other relief just and proper upon the premise.

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Clayton Louissaint Jean ("Respondent") is a nonresident producer holding license number 3966878 since December 11, 2023;

WHEREAS, Respondent's nonresident producer license expires March 31, 2026;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on October 8, 2025, the Commissioner mailed Respondent certified mail article # 9589 0710 5270 1823 1345 59 requesting a list of appointments to Respondent's address of record;

WHEREAS, on or about October 28, 2025, certified mail article # 9589 0710 5270 1823 1345 59 was returned to the Department marked as "Return to Sender, Refused, Unable to Forward";

WHEREAS, on December 24, 2025, the Commissioner sent electronic mail requesting a list of appointments to Respondent's electronic mail address of record;

WHEREAS, on December 24, 2025, the Commissioner received confirmation that delivery of the Commissioner's electronic mail to Respondent was complete;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3966878 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
