FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Kayla Nicole Stice ("Respondent") is a resident producer holding license number 880506 since May 15, 2013;

WHEREAS, Respondent's resident producer license expires October 31, 2027;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on March 30, 2026, the Commissioner sent a request for a list of appointments to Respondent's email address of record;

WHEREAS, on March 30, 2026, the Commissioner received confirmation that delivery of the Commissioner's email to Respondent was complete;

WHEREAS, on March 30, 2026, the Commissioner mailed Respondent certified mail article # 7022 2410 0002 7064 0478 requesting a list of appointments to Respondent's address of record;

WHEREAS, on April 2, 2026, the United States Postal Service delivered certified mail article # 7022 2410 0002 7064 0478 to Respondent;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 880506 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
