FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Carcar Markell Carmickal ("Respondent") is a nonresident producer holding license number 4039947 since August 29, 2024;

WHEREAS, Respondent's nonresident producer license expires September 30, 2026;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on April 13, 2026, the Commissioner emailed Respondent requesting a list of appointments to Respondent's email address of record;

WHEREAS, on April 13, 2026, the Commissioner received confirmation that delivery of the Commissioner's email to Respondent was complete;

WHEREAS, on May 11, 2026, the Commissioner mailed Respondent certified mail article # 9589 0710 5270 1821 8399 44 requesting a list of appointments to Respondent's address of record;

WHEREAS, on May 15, 2026, certified mail article # 9589 0710 5270 1821 8399 44 was delivered by the United States Postal Service;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 4039947 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
