FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Felicia Leonor Alonso Mendoza ("Respondent") is a resident producer holding license number 4090523 since March 6, 2025;

WHEREAS, Respondent's resident producer license expires November 30, 2027;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on April 1, 2026, the Commissioner emailed Respondent requesting a list of appointments to Respondent's email address of record;

WHEREAS, on April 1, 2026, the Commissioner received notification that said email was undeliverable with the error details stating, "The email account that you tried to reach does not exist";

WHEREAS, on May 7, 2026, the Commissioner mailed Respondent certified mail article # 9589 0710 5270 0977 1735 75 requesting a list of appointments to Respondent's address of record;

WHEREAS, on May 11, 2026, the United States Postal Service tracking for certified mail article # 9589 0710 5270 0977 1735 75 was marked as, "Addressee Unknown";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g);

WHEREAS, Indiana Code § 27-1-15.6-12(17) provides that the Commissioner may suspend a producer's license for failure to timely notify the Département of a change in address within thirty (30) days as required; and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 4090523 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
