FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Brian Dewitt Dixon ("Respondent") is a nonresident insurance producer holding license number 3342134 since May 24, 2018;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on April 10, 2026, the Commissioner emailed Respondent a request for a list of appointments to Respondent's email address of record;

WHEREAS, on April 10, 2026, the Department received confirmation that said email was successfully delivered;

WHEREAS, on April 10, 2026, the Commissioner mailed Respondent certified mail article # 95 8907 1052 7034 5068 9204 requesting a list of appointments to Respondent's address of record;

WHEREAS, on April 16, 2026, the status for certified mail article # 95 8907 1052 7034 5068 9204 was marked by the United States Postal Service as, "Refused";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3342134 is hereby suspended, effective immediately, and will remain suspended until the Commissioner receives Respondent's list of appointments.
