MOTION TO LIFT SUSPENSION ORDER

The Enforcement Division of Indiana Department of Insurance ("Department"), by counsel, Joseph Bossinger, now moves that the Suspension Order issued on May 26, 2026, in this matter be lifted. In support of this request the Department asserts the following:

1. Felicia Leonor Alonso Mendoza ("Respondent") is a resident insurance producer holding license number 4090523 since March 6, 2025.
2. On April 1, 2026, the Commissioner of the Indiana Department of Insurance ("Commissioner") sent an email to Respondent's email address of record requesting a list of appointments.
3. On April 1, 2026, the Commissioner received confirmation that delivery of said email was complete.
4. On May 7, 2026, the Commissioner mailed certified mail article # 9589 0710 5270 0977 1735 75 to Respondent's mailing address of record requesting a list of appointments.
5. On May 11, 2026, the United States Postal Service tracking for certified mail article # 9589 0710 5270 0977 1735 75 was marked as, "Addressee Unknown."

6. Respondent failed to provide the requested list of appointments not more than ten (10) days after receiving the Commissioner's request.
7. On May 26, 2026, pursuant to Indiana Code § 27-1-15.6-12(g), the Commissioner issued a Suspension Order suspending Respondent's license number 4090523 until such a time as the Commissioner received Respondent's list of appointments.
8. On June 29, 2026, Respondent sent an email to the Department providing a list of appointments.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and all other relief just and proper upon the premise.
