FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Anna Christine Rader ("Respondent") is a resident producer holding license number 4049106 since September 26, 2024;

WHEREAS, Respondent's resident producer license expires September 30, 2026;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on April 22, 2026, the Commissioner sent a request for a list of appointments to Respondent's email address of record;

WHEREAS, on April 22, 2026, the Commissioner received confirmation that delivery of the Commissioner's email to Respondent was complete;

WHEREAS, on June 11, 2026, the Commissioner mailed Respondent certified mail article # 9589 0710 5270 3450 6912 69 requesting a list of appointments to Respondent's address of record;

WHEREAS, after being marked by the United States Postal Service as, "Available for Pickup," certified mail article # 9589 0710 5270 3450 6912 69 was returned to the Department on June 25, 2026, with the tracking detail marked as, "Delivered to Original Sender";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 4049106 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
