FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Greiner Funeral Home & Cremation Services Inc ("Respondent") is a resident producer organization holding license number 3363216 since August 14, 2018;

WHEREAS, Respondent's resident producer license expires August 31, 2026;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on May 22, 2026, the Commissioner sent a request for a list of appointments to Respondent's email address of record;

WHEREAS, on May 22, 2026, the Commissioner received confirmation that delivery of the Commissioner's email to Respondent was complete;

WHEREAS, on May 22, 2026, the Commissioner mailed Respondent certified mail article #9589 0710 5270 3450 6895 01 requesting a list of appointments to Respondent's address of record;

WHEREAS, on June 7, 2026, certified mail article # #9589 0710 5270 3450 6895 01 was returned to the Department marked as "Not Deliverable as Addressed Unable to Forward";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3363216 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
