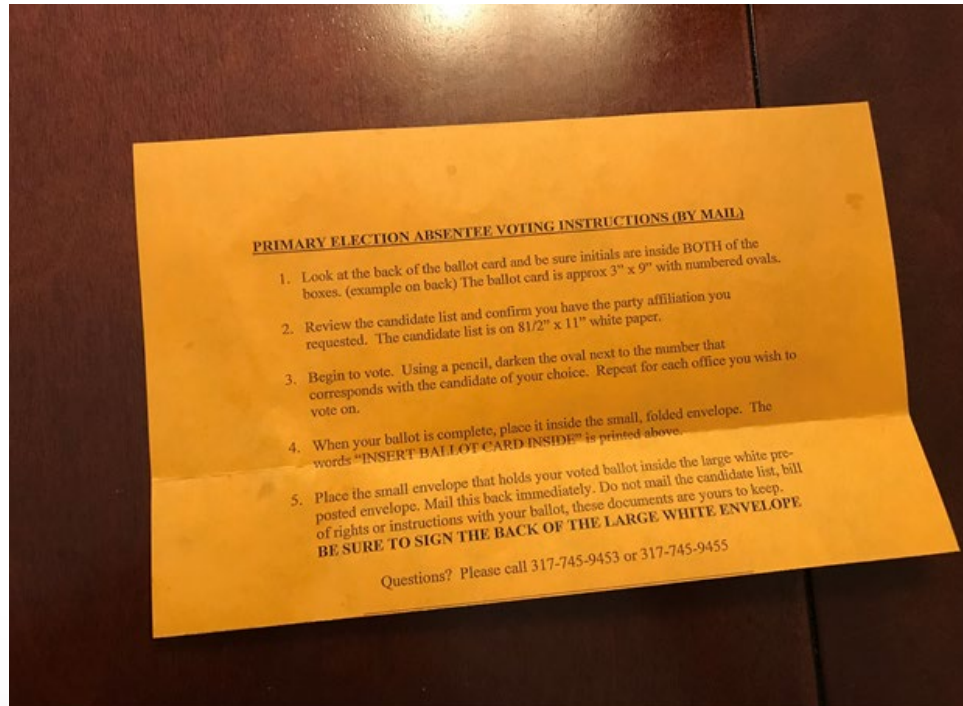

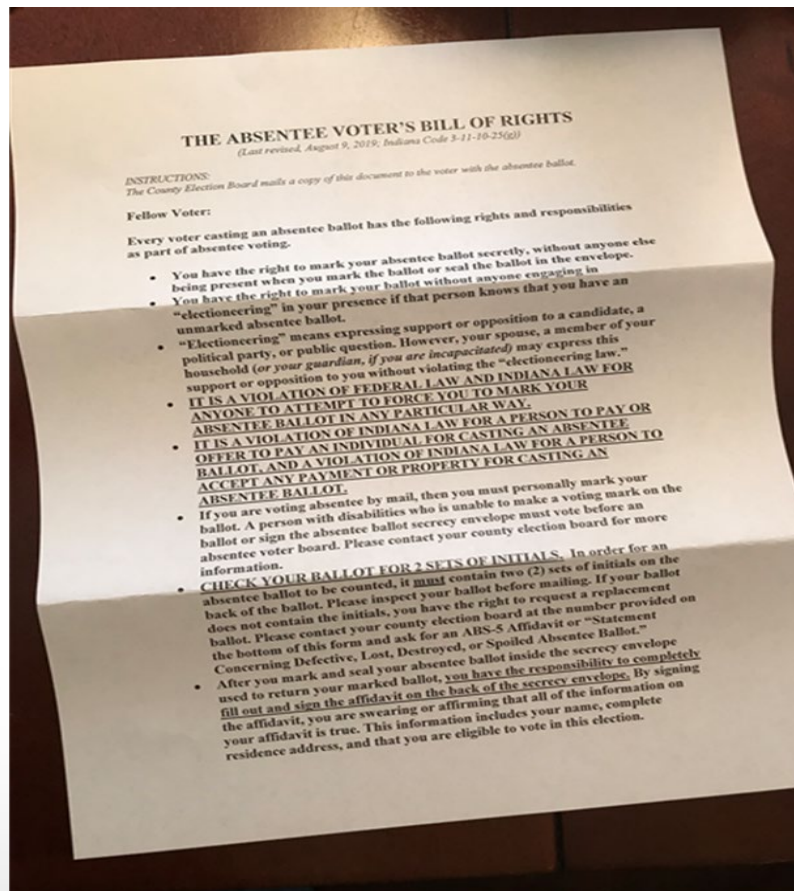

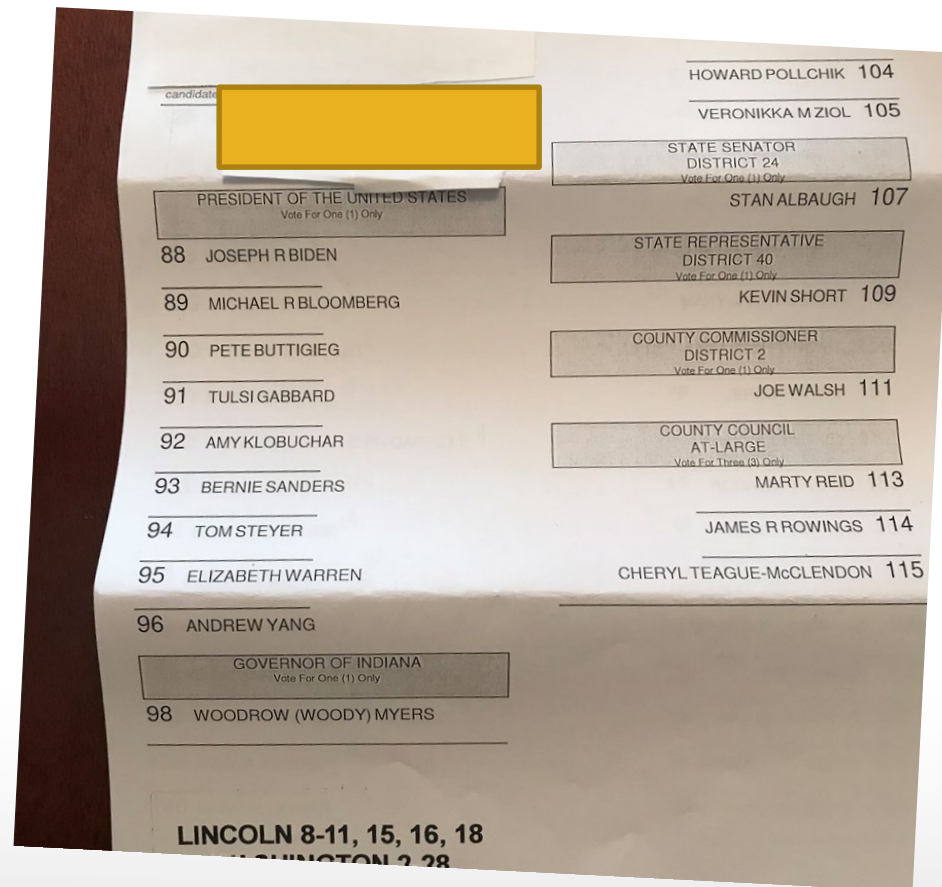

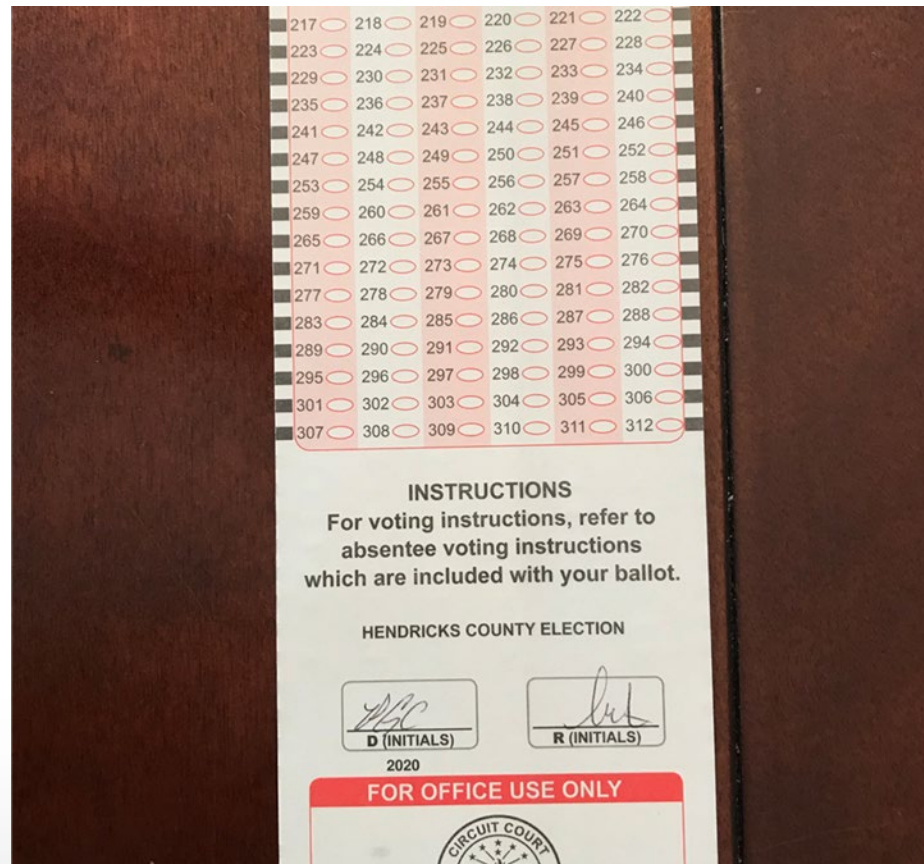

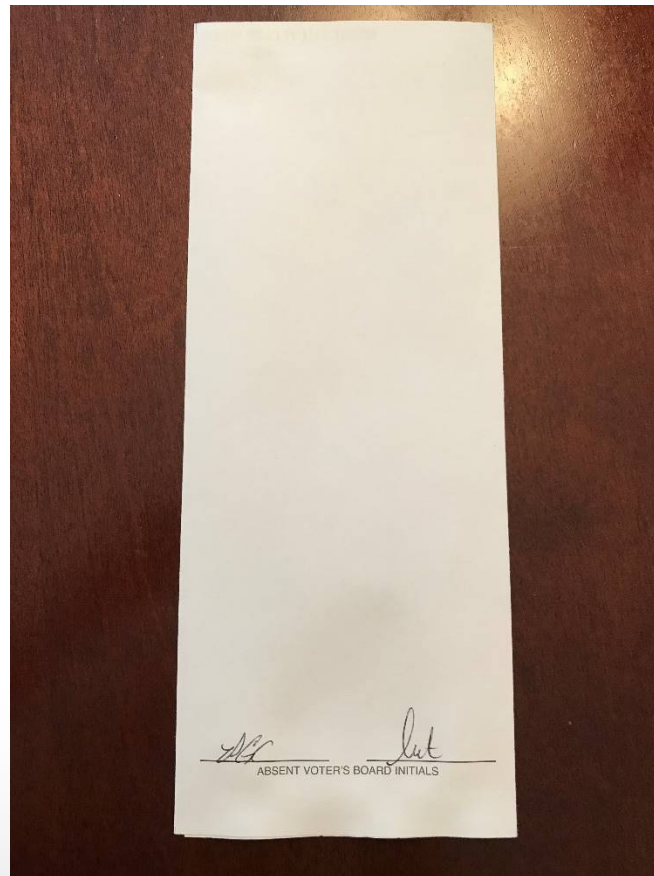

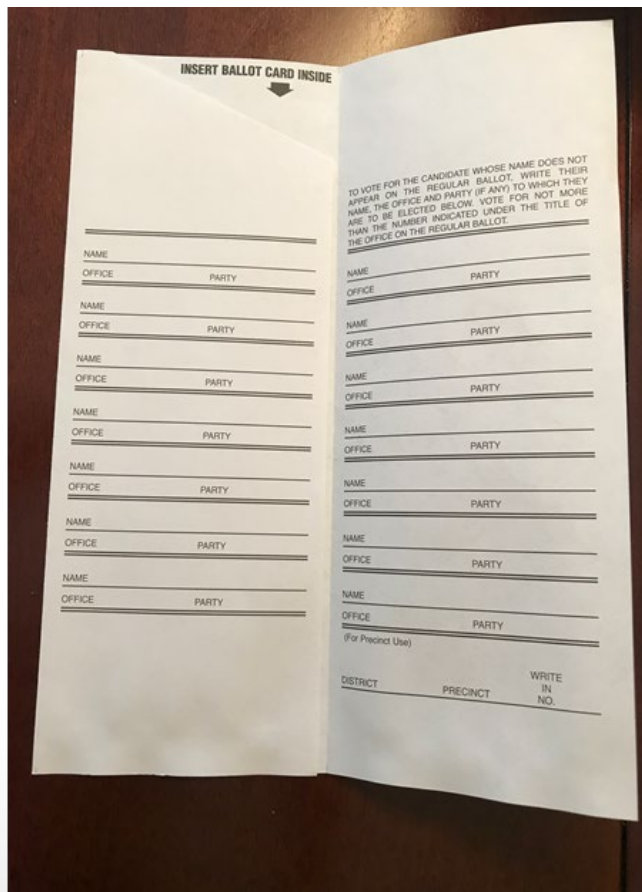
- Ballot Card Envelope (Front)

I am an Attorney General Confidentiality Program participant who resides in this precinct, and am entitled to use the above Post Office Box as my voting address.

**WARNING:** The individuals completing the affidavits above are affirming under the penalty of perjury. A person who makes a false, material statement under oath or affirmation, knowing the statement to be false or not believing it to be true commits perjury, a Level 6 felony, which is punishable by imprisonment for a term of up to two and one-half years, a fine of up to \$10,000 or both. (Indiana Code 35-44.1-2-1)

**WARNING:** Only a member of the voter's household, an employee of the United States Postal Service or an employee of a bonded courier company, or the individual designated as attorney in fact for the voter, may receive a ballot prepared by a voter for voting. If any other person receives from a voter a ballot prepared by a voter for voting, the person commits a Level 6 felony. (Indiana Code 3-14-2-16)

**TO THE INSPECTOR:** Open this envelope carefully. Do not deface or destroy the affidavit or the envelope. Take out the ballot enclosed, without unfolding or permitting the ballot to be unfolded or examined.
