PLEASE NOTE: In instances in which an LPN existed on multiple Accounts in the TSP1 system, the LPN and its associated account owner name was randomly selected from one of the accounts in order to determine the proper account type bucket the account should be applied to. In addition, if there was more than one LPN on a Registered ORB Account that had past due debts eligible for Placement in Collections, that Account was only counted once.
