



## **SPEAKER BIOS**

### **Lori Torres**

Lori A. Torres was appointed Inspector General by Governor Eric Holcomb effective January 9, 2017. She was a key member of the senior leadership team at the Indiana Department of Transportation immediately prior to her appointment, serving as General Counsel and Deputy Commissioner. She previously served as the Commissioner of the Indiana Department of Labor for six years under Governor Mitch Daniels.

She has practiced law for more than thirty years, including at Smart, Kessler & Torres in Johnson County for fifteen years and more recently at Ice Miller in Indianapolis.

She graduated Phi Beta Kappa from Indiana University Bloomington and received her law degree *cum laude* from the Indiana University Robert H. McKinney School of Law.

She is a resident of Johnson County.

### **Calvin Bellamy**

### **Steven Hunt**

Steven Hunt has been a Supervising Deputy Attorney General with the Medicaid Fraud Control Unit since November of 2003. He started as a supervisor and setup the new Evansville field office. He transferred in 2005 to the central Indianapolis Medicaid Fraud Control Unit office and took over as the supervisor of all the fraud investigators in central and southern Indiana while he continued to supervise the southern neglect/abuse investigators. He currently prosecutes civil health care fraud cases in state and federal courts. He acts as state investigative team leader in national health care fraud whistleblower cases in coordination with federal prosecution teams to recover tens (to hundreds) of millions of dollars of tax payer funds. Steve spent five years as a deputy prosecutor in Vanderburgh County, Indiana and tried over 65 felony jury trials. He specialized in homicides (incl. death penalty), sex crimes, violent crimes, vice, and OMOVIs. He has assisted in prosecutions all over the state, including working with the prosecutors in Grant, Lawrence, Dubois, Dearborn, Wayne, and Marion counties. Steve earned his J.D. from Indiana University School of Law - Indianapolis in 1998.

### **James Clevenger**

James Clevenger serves as Chairman of the State Ethics Commission. He was appointed to a four year term on the Commission by Governor Joseph Kernan in 2004 and reappointed to another four year term by Governor Mitch Daniels in 2008. In January of 2012 he was appointed as Chairman, and reappointed as Chairman in November of 2013. Mr. Clevenger has practiced law since 1978 and is a partner with the law offices of Wyland, Humphrey & Clevenger LLP in Plymouth, Indiana. He received his B.A. from Hanover College and his J.D. from Indiana University. He currently holds the position of County Attorney for Marshall County.

### **Tiffany Mulligan**

Tiffany Mulligan serves as the Chief Legal Counsel for the Office of Inspector General (OIG). In this role, she oversees the OIG's legal team and assists with cases involving waste, fraud, and abuse within the executive branch of state government.

Prior to joining the OIG, Tiffany was the General Counsel for the Indiana Family and Social Services Administration. She also served as the Associate General Counsel for Governor Mike Pence during his first year in office. Prior to joining the Governor's office, Tiffany worked as an attorney and Ethics Officer for the Indiana Department of Transportation (INDOT). While with INDOT, she served as the Director of the Economic Opportunity and Prequalification Divisions. In this role, she oversaw INDOT's Disadvantaged Business Enterprise program and its compliance with various civil rights laws. She also managed the financial and qualification-based review of potential bidders on INDOT's contracts and chaired the disciplinary proceedings of INDOT contractors and consultants.

Tiffany graduated magna cum laude from the Robert H. McKinney School of Law in Indianapolis in 2006. In 2004, she interned for Judge Kenneth Ripple of the U.S. Court of Appeals for the Seventh Circuit.

From 1997 to 2002, Tiffany was a legislative aide in Washington, D.C. She was the Assistant Legislative Director for U.S. Senator Richard Lugar and a Legislative Assistant for U.S. Congressman Mark Souder from northeast Indiana.
