CONFLICT OF INTEREST SCREEN FOR ALEC A'HEARN May 23, 2025

I. RECITALS

WHEREAS, Alec A'Hearn is a Design Engineer for the Indiana Department of Transportation ("INDOT" or "Department")-Fort Wayne District; and

WHEREAS, Alec A'Hearn has interviewed with Engineering Resources, Inc. ("ER"); and

WHEREAS, ER has a business relationship with INDOT, including active contracts; and

WHEREAS, as a design engineer for INDOT, it is possible that Alec A'Hearn could be assigned to participate in matters in which ER has an interest as part of his regular duties; and

WHEREAS, Alec A'Hearn's employment negotiations with ER create a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Alec A'Hearn is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including ER, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Alec A'Hearn may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.¹

NOW THEREFORE, Alec A'Hearn, Design Engineer for INDOT, for his remaining tenure with INDOT, or until he discontinues employment negotiations with ER, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Alec A'Hearn must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

II. CONFLICT OF INTEREST SCREEN

- 1. Alec A'Hearn shall not participate in any decision or vote, or any matter related to such decision or vote, in which ER has a financial interest.
- 2. Alec A'Hearn is screened from participating in any present or future contract or other matter involving ER.
- 3. Alec A'Hearn shall not assist any future employers, including ER, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Alec A'Hearn shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which ER has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with ER, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
