I. RECITALS

WHEREAS, Elsayed Abdel-Samad is a Highway Engineer-2 for the Indiana Department of Transportation-Greenfield District ("INDOT" or "Department"); and

WHEREAS, Elsayed Abdel-Samad recently accepted employment with Clark Dietz, Inc. ("Clark Dietz"); and WHEREAS, Clark Dietz has a business relationship with INDOT, including active contracts; and

WHEREAS, as a Highway Engineer-2 for INDOT Greenfield District, it is possible that Elsayed Abdel-Samad could be assigned to participate in matters in which Clark Dietz has an interest as part of his regular duties; and

WHEREAS, Elsayed Abdel-Samad's employment negotiations with Clark Dietz created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Elsayed Abdel-Samad is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including Clark Dietz, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Elsayed Abdel-Samad may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.¹

NOW THEREFORE, Elsayed Abdel-Samad, Highway Engineer-2 for INDOT, for his remaining tenure with INDOT, or until he discontinues employment negotiations with Clark Dietz, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen.
