# CONFLICT OF INTEREST SCREEN FOR KAYTI ADAMS

May 20, 2022

#### I. RECITALS

WHEREAS, Kayti Adams is a LPA Program Director for the Seymour District of the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Kayti Adams has entered employment negotiations with the Hannum, Wagle and Cline Engineering ("HWC" or "HWC Engineering"); and

WHEREAS, HWC has a business relationship with INDOT including active contracts with the Department; and WHEREAS, as LPA Program Director for INDOT- Seymour District, Kayti Adams could be assigned to work with HWC or to participate in matters in which the company has an interest as part of her regular duties; and

WHEREAS, Kayti Adams' employment negotiations with HWC created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, the State Ethics Commissioner determined in 2022-FAO-009 that the particular matter restriction under IC 4-2-6-11(a) does not apply to the position of INDOT LPA Program Director (aka Local Program Director); and

WHEREAS, Kayti Adams may have obtained confidential information in the course of her employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of herself or future employers.<sup>1</sup>

NOW THEREFORE, Kayti Adams, LPA Program Director for INDOT- Seymour District, for her remaining tenure with the Department, or until she discontinues employment negotiations with HWC Engineering, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Kayti Adams must adhere to terms three (3) in perpetuity, or until such time that the subject information is no longer deemed confidential.

## II. CONFLICT OF INTEREST SCREEN

- 1. Kayti Adams shall not participate in any decision or vote, or any matter related to such decision or vote, in which HWC Engineering has a financial interest.
- 2. Kayti Adams is screened from participating in any present/future contract or other matter involving HWC during her tenure with INDOT or until she discontinues negotiations with the entity.
- 3. Pursuant to her duty under Ind. Code §5-14-3-10, Kayti Adams shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

#### III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which HWC Engineering has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with HWC Engineering, whichever occurs first. I further understand that term three (3) regarding confidential information applies in perpetuity, so long as the subject information is deemed confidential. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
