CONFLICT OF INTEREST SCREEN FOR PAUL BALABA

I. RECITALS

WHEREAS, Paul Balaba is a Construction Project Manager for the Indiana Department of Transportation-Crawfordsville District ("INDOT" or "Department"); and

WHEREAS, Paul Balaba recently has been in discussions regarding potential employment with EGIS and HNTB, two engineering firms; and

WHEREAS, Both EGIS and HNTB has a business relationship with INDOT, including active contracts; and WHEREAS, as Construction Project Manager for INDOT, it is possible that Paul Balaba could be assigned to participate in matters in which EGIS or HNTB has an interest as part of his regular duties; and

WHEREAS, Paul Balaba's employment negotiations with EGIS and HNTB created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Paul Balaba is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including EGIS and HNTB, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Paul Balaba may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.¹

NOW THEREFORE, Paul Balaba, Construction Project Manager for INDOT, for his remaining tenure with INDOT, or until he discontinues employment negotiations with EGIS or HNTB, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Paul Balaba must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

II. CONFLICT OF INTEREST SCREEN

- 1. Paul Balaba shall not participate in any decision or vote, or any matter related to such decision or vote, in which EGIS or HNTB has a financial interest.
- 2. Paul Balaba is screened from participating in any present or future contract or other matter involving EGIS or HNTB.
- 3. Paul Balaba shall not assist any future employers, including EGIS and HNTB, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Paul Balaba shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which EGIS or HNTB has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with EGIS, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential. I have shared and discussed this Conflict-of-Interest Screen and its requirements with my supervisor.
