 Dustin Bewley is a Project Manager for the Indiana Department of Transportation (INDOT)- Crawfordsville District.  
 Dustin Bewley has entered employment negotiations with Parsons Corporation ("Parsons"). Parsons has a business relationship with INDOT, including active contracts with the Department.  
 Dustin Bewley's employment negotiations with Parsons created a potential decisions and voting conflict of interest under IC 4-2-6-9. This disclosure is therefore being filed in anticipation of that potential conflict.  
 Dustin Bewley is not subject to the mandatory cooling off period (IC 4-2-6-11(b)) with respect to Parsons.  
 Dustin Bewley is subject to the particular matter restriction and will not assist future employers, including Parsons, with any matter he personally and substantially participated in on behalf of INDOT.  
 This disclosure was provided to Dustin Bewley's appointing authority, Commissioner Joe McGuinness, on July 30, 2021.



**CONFLICT OF INTEREST SCREEN FOR DUSTIN BEWLEY**

**I. RECITALS**

WHEREAS, Dustin Bewley is a Project Manager for the Indiana Department of Transportation- Crawfordsville District ("INDOT" or "Department"); and  
WHEREAS, Dustin Bewley has accepted a position with Parsons Corporation ("Parsons"); and  
WHEREAS, Parsons has a business relationship with INDOT, including ongoing contracts with the Department;  
and  
WHEREAS, as a Project Manager for INDOT, it is possible that Dustin Bewley could be assigned to work with Parsons or to participate in matters involving the company as part of his regular duties; and  
WHEREAS, Dustin Bewley's employment negotiations with Parsons created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and  
WHEREAS, Dustin Bewley is subject to the particular matter restriction under IC 4-2-6-11(a) and cannot assist future employers, including Parsons, with any matter he personally and substantially participated in while employed by INDOT.

NOW THEREFORE, Dustin Bewley, a Project Manager, for his remaining tenure with the Department, or until he discontinues employment negotiations with Parsons Corporation, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Dustin Bewley must adhere to term three (3) regarding the particular matter restriction in perpetuity, for the life of each particular matter.


**II. CONFLICT OF INTEREST SCREEN**

1. Dustin Bewley shall not participate in any decision or vote, or any matter related to such decision or vote, in which Parsons has a financial interest.
2. Dustin Bewley should be screened from participating in any present or future contract or other matter involving Parsons.
3. Dustin Bewley shall not assist any future employers, including Parsons, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.

**III. EMPLOYEE AFFIRMATION**

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which Parsons Corporation has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with Parsons, whichever occurs first. I further understand that term three (3) concerning the particular matter restrict applies in perpetuity, for the life of the matter. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
