Megan Bolyard recently entered employment negotiations with BF&S Civil Engineers ("BF&S"). BF&S is an INDOT vendor and has active contracts with the Department. Megan Bolyard has worked with BF&S as an INDOT employee but is not in a position to make discretionary decisions within the scope of the cooling off period. As such, Megan Bolyard's employment negotiations with BF&S created a potential decisions and voting conflict under IC 4-2-6-9; this disclosure is being filed in anticipation of that apparent conflict. Megan Bolyard is not subject to the mandatory cooling off period (IC 4-2-6-11(b)) as Erosion and Sediment Control Specialist. Megan Bolyard is subject to the particular matter restriction and will not assist future employers, including BF&S, with any INDOT matter that she personally and substantially participated in as Erosion and Sediment Control Specialist. This disclosure was provided to Megan Bolyard's appointing authority, Commissioner Michael J. Smith, on June 9, 2022. Evidence of said disclosure to Commissioner Smith is filed herewith pursuant to IC 4-2-6-9(b)(2)(D). CONFLICT OF INTEREST SCREEN FOR MEGAN BOLYARD

I. RECITALS

WHEREAS, Megan Bolyard is Erosion and Sediment Control Specialist for the Crawfordsville District of the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Megan Bolyard has entered employment negotiations with the BF&S Civil Engineering ("BF&S"); and

WHEREAS, BF&S has a business relationship with INDOT including active contracts with the Department; and WHEREAS, as Erosion and Sediment Control Specialist for INDOT- Crawfordsville District, Megan Bolyard could be assigned to work with BF&S or to participate in matters in which the company has an interest as part of her regular duties; and

WHEREAS, Megan Bolyard' employment negotiations with BF&S created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, the particular matter restriction under IC 4-2-6-11(c) applies to Megan Bolyard as Erosion and Sediment Control Specialist; and

WHEREAS, Megan Bolyard may have obtained confidential information in the course of her employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of herself or future employers.¹

NOW THEREFORE, Megan Bolyard, Erosion and Sediment Control Specialist for INDOT- Crawfordsville District, for her remaining tenure with the Department, or until she discontinues employment negotiations with BF&S Civil Engineering, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Megan Bolyard must adhere to term three (3) in perpetuity, for the life of the particular matter, and term four (4) in perpetuity, or until such time that the subject information is no longer deemed confidential.

II. CONFLICT OF INTEREST SCREEN

- 1. Megan Bolyard shall not participate in any decision or vote, or any matter related to such decision or vote, in which BF&S has a financial interest.
- 2. Megan Bolyard is screened from participating in any present/future contract or other matter involving BF&S during her tenure with INDOT or until she discontinues negotiations with the entity.
- 3. Megan Bolyard shall not assist any future employers, including BF&S, with any matter she personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to her duty under Ind. Code §5-14-3-10, Megan Bolyard shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which BF&S Civil Engineering has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with BF&S, whichever occurs first. I further understand that term three (3) regarding the particular matter restriction applies in perpetuity, and term four (4) regarding confidential information applies in perpetuity, so long as the subject information is deemed confidential. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
