As a result, I have been looking both inside and outside the State for employment opportunities. I applied for a position with the Conservation Law Center (CLC), which is sometimes involved in administrative case the Natural Resources Commission. There was an ongoing proceeding involving the CLC, from which I promptly recused myself on May 16, 2025. The matter has already been reassigned to a new Administra the Office of Administrative Law Proceedings. I have had no involvment with the case since my recusal. The CLC, despite my offer to withdraw the application, approached me about entering into employment negotiations. I am interested in the position and plan to continue speaking with the CLC about prospection employment. After submitting an informal ethics review request to the Office of the Inspector General, I was informed that I needed to submit this form and notify both the in-house ethics officer at the Divisia of Hearings as well as the Director of the Department of Natural Resources. Please see the notification I sent to both people attached to this form. As discussed below, I will refrain from discussing the pending administrative case with the CLC and will divulge any sensitive information if offered the position.

After discussing this potential conflict of interests with Elizabeth Gamboa, the Hearing Division's Ethics Officer, we
agreed to establish the following screen:
1. I will not discuss the pending case involving the CLC during negotiations and if offered the position. If the CLC team
members need to discuss that case, I will promptly leave any meetings and recuse myself from those discussions.
2. I will not discuss any sensitive information regarding the Department of Natural Resources, the Natural Resources
Commission, or any other agency/State body with the CLC regarding any pending matters.
3. While lobbying should not be an issue, I will refrain from any executive branch or legislative branch lobbying on behalf of
the CLC for at least one year.
4. If any ethics concerns arise that I have not contemplated, I will notify the CLC and the State as appropriate and as
as needed.

This email disclosure and notification is being sent to you as the Director of the Department of Natural Resources in compliance with IC 4-2-6-6, IC 4-2-6-9, 42 IAC 1-5-10, and 42 IAC 1-5-11. It will also be filed with the Inspector General's office as part of State Form 55860 (R/ 10-15).

As you may or may not be aware, there was an administrative proceeding in the Natural Resources Commission Hearings Division involving the CLC.
