Jered Brown recently accepted employment with RQAW Corporation ("RQAW") RQAW has a business relationship with INDOT, including active contracts with the Department. Jered Brown's employment negotiations with RQAW therefore created a potential decisions and voting conflict of interest under IC 4-2-6-9. This disclosure is therefore being filed in anticipation of that potential conflict. Jered Brown has not worked with RQAW in the last two (2) years as an INDOT employee. Therefore he is not subject to the mandatory cooling off period (IC 4-2-6-11(b)). Jered Brown is subject to the particular matter restriction and will not assist future employers, including RQAW, with any matter he personally and substantially participated in on behalf of INDOT. CONFLICT OF INTEREST SCREEN FOR JERED BROWN

I. RECITALS

WHEREAS, Jered Brown is Project Supervisor for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Jered Brown recently accepted employment with RQAW Corporation ("RQAW"); and WHEREAS, RQAW has a business relationship with INDOT, including active contracts; and

WHEREAS, as Project Supervisor for INDOT, it is possible that Jered Brown could be assigned to participate in matters in which ROAW has an interest as part of his regular duties; and

WHEREAS, Jered Brown's employment negotiations with RQAW created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Jered Brown is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including RQAW, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Jered Brown may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.¹

NOW THEREFORE, Jered Brown, Project Supervisor for INDOT, for his remaining tenure with INDOT, or until he discontinues employment negotiations with RQAW Corporation, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Jered Brown must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

II. CONFLICT OF INTEREST SCREEN

- 1. Jered Brown shall not participate in any decision or vote, or any matter related to such decision or vote, in which RQAW has a financial interest.
- 2. Jered Brown is screened from participating in any present or future contract or other matter involving RQAW.
- 3. Jered Brown shall not assist any future employers, including RQAW, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Jered Brown shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which RQAW Corporation has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with RQAW, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential.
