Mallory Duncan recently entered employment negotiations with HNTB Corporation ("HNTB"). HNTB has a business relationship with INDOT, including active contracts with the Department. Mallory Duncan's employment negotiations with HNTB therefore created a potential decisions and voting conflict of interest under IC 4-2-6-9. This disclosure is therefore being filed in anticipation of that potential conflict. Mallory Duncan is not subject to the mandatory cooling off period (IC 4-2-6-11(b)) as Strategic Communications Director. Mallory Duncan is subject to the particular matter restriction and will not assist future employers, including HNTB, with any matter she personally and substantially participated in on behalf of INDOT. This disclosure was provided to Mallory Duncan's appointing authority, Commissioner Michael J. Smith, on May 2, 2022. I. RECITALS

WHEREAS, Mallory Duncan is Strategic Communications Director for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Mallory Duncan has entered employment negotiations with HNTB Corporation ("HNTB"); and WHEREAS, HNTB has a business relationship with INDOT, including active contracts; and

WHEREAS, as Strategic Communications Director for INDOT, it is possible that Mallory Duncan could participate in matters in which HNTB has an interest as part of her regular duties; and

WHEREAS, Mallory Duncan's employment negotiations with HNTB created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Mallory Duncan is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including HNTB, with any matter she personally and substantially participated in for INDOT; and

WHEREAS, Mallory Duncan may have obtained confidential information in the course of her employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of herself or future employers. ¹

NOW THEREFORE, Mallory Duncan, Strategic Communications Director for INDOT, for her remaining tenure with INDOT, or until she discontinues employment negotiations with HNTB Corporation, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Mallory Duncan must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

II. CONFLICT OF INTEREST SCREEN

- 1. Mallory Duncan shall not participate in any decision or vote, or any matter related to such decision or vote, in which HNTB has a financial interest.
- 2. Mallory Duncan is screened from participating in any present or future contract or other matter involving HNTB.
- 3. Mallory Duncan shall not assist any future employers, including HNTB, with any matter she personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to her duty under Ind. Code §5-14-3-10, Mallory Duncan shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.
