CONFLICT OF INTEREST SCREEN FOR KEVIN ESTELLE

I. RECITALS

WHEREAS, Kevin Estelle is a Highway Technician for the Indiana Department of Transportation-Greenfield District ("INDOT" or "Department"); and

WHEREAS, Kevin Estelle has entered employment negotiations with Resolution Group, Inc.; and WHEREAS, Resolution Group has a business relationship with INDOT, including active contracts; and WHEREAS, as a Highway Technician for INDOT, it is possible that Kevin Estelle could participate in matters in which Resolution Group has an interest as part of his regular duties; and

WHEREAS, Kevin Estelle's employment negotiations with Resolution Group created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Kevin Estelle is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including Resolution Group, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Kevin Estelle may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.¹

NOW THEREFORE, Kevin Estelle, Highway Technician for INDOT- Greenfield District, for his remaining tenure with INDOT, or until he discontinues employment negotiations with Resolution Group, Inc., agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Kevin Estelle must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

II. CONFLICT OF INTEREST SCREEN

- 1. Kevin Estelle shall not participate in any decision or vote, or any matter related to such decision or vote, in which Resolution Group, Inc. has a financial interest.
- 2. Kevin Estelle is screened from participating in any present or future contract or other matter involving Resolution Group, Inc.
- Kevin Estelle shall not assist any future employers, including Resolution Group, Inc., with any matter he personally
 and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the
 particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Kevin Estelle shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which Resolution Group, Inc. has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with Resolution Group, Inc., whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential.
