## CONFLICT OF INTEREST SCREEN FOR TED GRAY

February 28, 2023

#### I. RECITALS

WHEREAS, Ted Gray is a Construction Project Manager for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Ted Gray entered employment negotiations with Lochmueller Group, Inc. ("Lochmueller"); and WHEREAS, Lochmueller has a business relationship with INDOT, including active contracts; and

WHEREAS, as a Construction Project Manager for INDOT, it is possible that Ted Gray could participate in matters in which Lochmueller has an interest as part of his regular duties; and

WHEREAS, Ted Gray's employment negotiations with Lochmueller created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Ted Gray is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including Lochmueller, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Ted Gray may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.<sup>1</sup>

NOW THEREFORE, Ted Gray, Construction Engineer for INDOT, for his remaining tenure with INDOT, or until he discontinues employment negotiations with Lochmueller Group, Inc., agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Ted Gray must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

#### II. CONFLICT OF INTEREST SCREEN

- 1. Ted Gray shall not participate in any decision or vote, or any matter related to such decision or vote, in which Lochmueller has a financial interest.
- 2. Ted Gray is screened from participating in any present or future contract or other matter involving Lochmueller.
- 3. Ted Gray shall not assist any future employers, including Lochmueller, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Ted Gray shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

### III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which Lochmueller Group, Inc. has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with Lochmueller, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
