# CONFLICT OF INTEREST SCREEN FOR LUCAS HOWDER August 20, 2023

## 1. RECITALS

WHEREAS, Lucas Howder is a Project Supervisor for the Indiana Department of Transportation-Vincennes District ("INDOT" or "Department"); and

WHEREAS, Lucas Howder recently accepted employment with HNTB Corporation; and

WHEREAS, HNTB has a business relationship with INDOT, including active contracts; and

WHEREAS, as Project Supervisor for INDOT, it is possible that Lucas Howder could participate in matters in which HNTB has an interest as part of his regular duties; and

WHEREAS, Lucas Howder's employment negotiations with HNTB created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHERAS, in his role as Project Supervisor it is possible that Lucas Howder could be assigned to contracts and other matters in which HNTB has an interest and needs to be proactively screened from participation in any matter in which HNTB has an interest; and

WHEREAS, Lucas Howder is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including HNTB, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Lucas Howder may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.

NOW THEREFORE, Lucas Howder, Project Supervisor for INDOT, for his remaining tenure with INDOT, or until he discontinues employment negotiations with HNTB Corporation, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Lucas Howder must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

### II. CONFLICT OF INTEREST SCREEN

- Lucas Howder shall not participate in any decision or vote, or any matter related to such decision or vote, in which HNTB has a financial interest.
- Lucas Howder is screened from participating in any present or future contract or other matter involving HNTB.
- 3. Lucas Howder shall not assist future employers, including HNTB, with

any matter he personally and substantially participated in as an INDOT employee. This restriction applies for the life of the matter.

4. Pursuant to his duty under Ind. Code §5-14-3-10, Lucas Howder shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

# III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which HNTB Corporation has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with HNTB, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
