#### I. RECITALS

WHEREAS, Jason Kruse is Statewide Fleet Director for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Jason Kruse accepted a position with MacAllister Machinery Company, Inc. ("MacAllister"); and WHEREAS, MacAllister has a business relationship with INDOT; and

WHEREAS, as Statewide Fleet Director for INDOT, it is possible that Jason Kruse could be assigned to work with MacAllister or to participate in matters in which the company has an interest as part of his regular duties; and

WHEREAS, Jason Kruse's employment negotiations with MacAllister created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Jason Kruse is subject to the particular matter restriction under IC 4-2-6-11(a) and cannot assist future employers, including MacAllister Machinery Company, Inc., with any matter he personally and substantially participated in while employed by INDOT; and

WHEREAS, Jason Kruse had minimal, indirect, and tangential involvement in the award and administration of that certain procurement agreement with MacAllister referred to as INDOT QPA No. 22-060, the employee is not prohibited from representing MacAllister with regard to said matter in his future employment role with the company.

NOW THEREFORE, Jason Kruse, Statewide Fleet Director, for his remaining tenure with the Department, or until he discontinues employment negotiations with MacAllister Machinery Company, Inc., agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Jason Kruse must adhere to term three (3) regarding the particular matter restriction in perpetuity, for the life of each particular matter.

#### II. CONFLICT OF INTEREST SCREEN

- 1. Jason Kruse shall not participate in any decision or vote, or any matter related to such decision or vote, in which MacAllister Machinery Company, Inc. has a financial interest.
- 2. Jason Kruse should be screened from participating in any present or future contract or other matter involving MacAllister Machinery Company, Inc.
- 3. Jason Kruse shall not assist any future employers, including MacAllister Machinery Company, Inc., with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter. The particular matter restriction does not apply to INDOT QPA 22-060, as Jason Kruse did not have personal and substantial involvement in the matter as INDOT's Statewide Fleet Director.

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which MacAllister Machinery Company, Inc. has a financial interest.
