CONFLICT OF INTEREST SCREEN FOR ANURADHA KUMAR April 19, 2022

I. RECITALS

WHEREAS, Anuradha Kumar is Manager of the Cultural Resource Office for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Anuradha Kumar has entered employment negotiations with Parsons Corporation ("Parsons"); and WHEREAS, Parsons has a business relationship with INDOT, including active contracts; and

WHEREAS, as Manager of the Cultural Resource Office for INDOT, it is possible that Anuradha Kumar could participate in matters in which Parsons has an interest as part of her regular duties; and

WHEREAS, Anuradha Kumar's employment negotiations with Parsons created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Anuradha Kumar is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including Parsons, with any matter she personally and substantially participated in for INDOT; and

WHEREAS, Anuradha Kumar may have obtained confidential information in the course of her employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of herself or future employers.¹
