# CONFLICT OF INTEREST SCREEN FOR MARLENE MATHAS March 15, 2022

#### I. RECITALS

WHEREAS, Marlene Mathas is a Major Project/LPA Review Liaison for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Marlene Mathas has entered employment negotiations with SESCO Group ("SESCO"); and WHEREAS, SESCO has a business relationship with INDOT; and

WHEREAS, as a Major Project/LPA Review Liaison for INDOT, it is possible that Marlene Mathas could be assigned to work with SESCO or to participate in matters in which the company has an interest as part of her regular duties; and

WHEREAS, Marlene Mathas' employment negotiations with SESCO created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Marlene Mathas is subject to the particular matter restriction under IC 4-2-6-11(a) and cannot assist future employers, including SESCO, with any matter she personally and substantially participated in for INDOT; and

WHEREAS, Marlene Mathas may have obtained confidential information in the course of her employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of herself or future employers.<sup>1</sup>

NOW THEREFORE, Marlene Mathas, Major Project/LPA Review Liaison for INDOT, for her remaining tenure with the Department, or until she discontinues employment negotiations with SESCO Group, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Marlene Mathas must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

#### II. CONFLICT OF INTEREST SCREEN

- 1. Marlene Mathas shall not participate in any decision or vote, or any matter related to such decision or vote, in which SESCO Group has a financial interest.
- 2. Marlene Mathas is screened from participating in any present or future contract or other matter involving SESCO.
- 3. Marlene Mathas shall not assist any future employers, including SESCO, with any matter she personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to her duty under Ind. Code §5-14-3-10, Marlene Mathas shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

#### III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which SESCO Group has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with SESCO Group, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each subject matter and so long as the subject information is deemed confidential. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
