WHEREAS, Melissa Patton is a Project Manager for the Indiana Department of Transportation- Crawfordsville District ("INDOT" or "Department"); and

WHEREAS, Melissa Patton has accepted a position with Rieth-Riley Construction Co. ("Rieth-Riley)"; and WHEREAS, Rieth-Riley has a business relationship with INDOT, including ongoing contracts with the Department; and

WHEREAS, as a Project Manager for INDOT, it is possible that Melissa Patton could be assigned to work with Rieth-Riley or to participate in matters in which the company has an interest as part of her regular duties; and

WHEREAS, Melissa Patton's employment negotiations with Rieth-Riley created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Melissa Patton is subject to the particular matter restriction under IC 4-2-6-11(a) and cannot assist future employers, including Rieth-Riley, with any matter she personally and substantially participated in while employed by INDOT.

NOW THEREFORE, Melissa Patton, a Project Manager, for her remaining tenure with the Department, or until she discontinues employment negotiations with Rieth-Riley Construction Co., agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen.
