# CONFLICT OF INTEREST SCREEN FOR COREY SCHAMBERGER April 17, 2023

#### I. RECITALS

WHEREAS, Corey Schamberger is a Construction Project Engineer for the Indiana Department of Transportation-Ft. Wayne District ("INDOT" or "Department"); and

WHEREAS, Corey Schamberger entered employment negotiations with Fox Contractors Corp ("Fox"); and WHEREAS, Fox has a business relationship with INDOT, including active contracts; and

WHEREAS, as a Construction Project Engineer for INDOT, it is possible that Corey Schamberger could participate in matters in which Fox has an interest as part of his regular duties; and

WHEREAS, Corey Schamberger's employment negotiations with Fox created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Corey Schamberger is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including Fox, with any matter he personally and substantially participated in for INDOT; and

WHEREAS, Corey Schamberger may have obtained confidential information in the course of his employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of himself or future employers.<sup>1</sup>

NOW THEREFORE, Corey Schamberger, Construction Project Engineer for INDOT, for his remaining tenure with INDOT, or until he discontinues employment negotiations with Fox Contractors Corp, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Corey Schamberger must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

#### II. CONFLICT OF INTEREST SCREEN

- 1. Corey Schamberger shall not participate in any decision or vote, or any matter related to such decision or vote, in which Fox has a financial interest.
- 2. Corey Schamberger is screened from participating in any present or future contract or other matter involving Fox.
- 3. Corey Schamberger shall not assist any future employers, including Fox, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Corey Schamberger shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

#### III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which Fox Contractors Corp has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with Fox, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential.
