I. RECITALS

WHEREAS, Shawn Slaymon is Stormwater Team Lead for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Shawn Slaymon has entered employment negotiations with GAI Consultants, Inc. ("GAI"); and WHEREAS, GAI has a business relationship with INDOT, including active contracts; and

WHEREAS, as Stormwater Team Lead for INDOT, it is possible that Shawn Slaymon could participate in matters in which GAI has an interest as part of his regular duties; and

WHEREAS, Shawn Slaymon's employment negotiations with GAI created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Shawn Slaymon is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including GAI, with any INDOT matter he personally and substantially participated in for the Department; and
