# Protocol to Screen the Indiana Department of Environmental Management's Office of Legal Counsel's Kyle Tucker from Any Matters Regarding Allison Transmission, Inc

Mr. Kyle Tucker is an attorney for the Office of Legal Counsel (OLC) at the Indiana Department of Environmental Management (IDEM). Mr. Tucker's duties include representing IDEM in enforcement cases and permit appeals.

Mr. Tucker has accepted a position at Allison Transmission, Inc. (Allison), a transmission manufacturing company that holds several permits administered by IDEM. Because Mr. Tucker is currently representing IDEM in two permit appeals involving Allison, including appeals under No. 097-47504-00310 and No. 097-47474-00310, which have been consolidated under cause number 24-A-J-5283, per IC 4-2-6-9, IDEM is instituting the following to ensure Mr. Tucker is screened from any conflict of interest with Allison.


- 1. IDEM OLC Section Chief Stephen Thill (SC Thill) is Mr. Tucker's direct supervisor. SC Thill will not assign any current or future matter that may arise involving Allison, or any of its clients, to Mr. Tucker.
- 2. Mr. Tucker shall recuse himself from the portion of any meeting at IDEM in which discussions specific to Allison, or in which any of its clients, subsidiaries, or interests are discussed or are expected to be discussed.
- 3. Mr. Tucker shall not discuss any matter involving Allison, or any of its clients, with any other IDEM employee.
- 4. SC Thill will notify in writing all employees in his supervisory chain that they are not to discuss any matters involving Allison, or any of its clients, with Mr. Tucker, nor send him any emails concerning Allison.
- 5. Mr. Tucker shall not participate in decisions regarding or relating to Allison, or any of its clients.
- 6. Mr. Tucker shall not access any correspondence or files relating to or involving Allison, or any of its clients, either during his hours of work at IDEM or by utilizing State equipment. Such documents, if not a matter of public record in IDEM's Virtual File Cabinet, shall be housed with the employee assigned to the matter or kept where Mr. Tucker does not have access to alter the documents.
- 7. Mr. Tucker shall immediately inform SC Thill and IDEM Ethics Officer James French if any provision of this screening protocol is violated.
- 8. Mr. Tucker shall follow IC 4-2-6-9(b) and file a written disclosure statement with the State Ethics Commission.
- 9. All signatories to this screening protocol shall review it within thirty (30) days from the date of the last signature to assure it has been followed and determine if the circumstances have changed to make the protocol no longer necessary.
