Protocol to Screen IDEM Employee Corey Webb from Any Matters Regarding the Hoosier Environmental Council

Mr. Corey Webb is the Deputy Assistant Commissioner of the Office of Land Quality ("OLQ") within the Indiana Department of Environmental Management ("IDEM"). He has been approached by an employment service about the position of Executive Director of the Hoosier Environmental Council ("HEC"). The HEC is an environmental advocacy organization within the State of Indiana. Although not regulated by the IDEM, the HEC has met periodically with IDEM staff regarding areas of environmental concern and has been involved with the IDEM in litigation. Mr. Webb at this time is determining his interest in the position and will soon meet with those who have shown an interest in him for the position.

During the course of his duties at the IDEM, Mr. Webb could be called upon to meet with HEC representatives regarding environmental matters. Therefore, to prevent even a perception of a conflict of interest, the IDEM shall implement the following protocol to screen Mr. Webb from any matter that may arise regarding the Hoosier Environmental Council.

- 1. In accordance with IC 4-2-6-9(b), Mr. Webb shall notify IDEM Commissioner Brian Rockensuess and Assistant Commissioner of OLQ Peggy Dorsey that he is pursuing an interest in potential employment with the HEC.
- 2. Assistant Commissioner Dorsey shall not involve Mr. Webb in any issue that may arise regarding the HEC.
- 3. Mr. Webb shall recuse himself from the portion of any meeting in which discussions specific to the HEC are discussed or are expected to be discussed.
- 4. Mr. Webb shall not discuss any matter involving the HEC with any IDEM employee.
- 5. Mr. Webb shall not attend any meeting between the IDEM and the HEC.
- 6. Mr. Webb shall not access any correspondence or files relating to or involving the HEC.
- 7. Mr. Webb shall not participate in decisions regarding or relating to the HEC.
- 8. Mr. Webb shall immediately inform his supervisor Assistant Commissioner Peggy Dorsey and the IDEM Ethics Officer Kathleen Mills if any provision of this screening protocol is violated.
- 9. Mr. Webb shall follow IC 4-2-6-9(b) and file a written disclosure statement with the State Ethics Commission.

- 10. Should Mr. Webb decide to apply for the position, he shall notify the HEC that he has screened himself from any matters that might involve the HEC while he is a candidate for the position.
- 11. Mr. Webb and Chief Ethics Officer Mills shall review this screening protocol within 30 days from the date of the last signature to assure this protocol has been followed and determine if the protocol should continue.
