Wayne District of the Indiana Department of Transportation. Ryan Bol recently accepted employment with Michiana Contracting, Inc. ("Michiana"), a company that does business with INDOT. Mr. Bol has overseen one INDOT contract (T-41218) with Michiana in his capacity as Construction Engineer, but did not have the requisite discretionary authority to preclude him from accepting immediate employment with Michiana under IC 4-2-6-11(b). Ryan Bol's employment negotiations with Michiana created a potential decisions and voting conflict of interest under IC 4-2-6-9, requiring the filing of this disclosure in anticipation of said conflict. As stated above, Mr. Bol is not subject to the mandatory cooling off period (IC 4-2-6-11(b)) in his position as a Construction Engineer with INDOT. The employee is subject to the particular matter restriction and will not assist any future employer with a matter he personally and substantially participated in on behalf of INDOT. This disclosure was provided to Ryan Bol's appointing authority, Commissioner Joe McGuinness, on March 19, 2021. Evidence of said disclosure to Commissioner McGuinness is filed herewith pursuant to IC 4-2-6-9(b)(2)(D). Pursuant to IC 4-2-6-9(b)(2), this disclosure was executed and filed with the SEC within seven days (7) of the potential conflict being identified by the below signed ethics officer.

I. RECITALS

WHEREAS, Ryan Bol is a Construction Engineer for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Ryan Bol has accepted a position with Michiana Contracting, Inc. ("Michiana"); and WHEREAS, Michiana has a business relationship with INDOT, including ongoing contracts with the Department;

WHEREAS, as a Construction Engineer for INDOT, it is possible that Ryan Bol could be assigned to work with Michiana or to participate in matters involving the company as part of his regular duties; and

WHEREAS, Ryan Bol is assigned to and has administered INDOT Contract T-41218, which was awarded to and completed by Michiana; and

WHEREAS, work on INDOT Contract T-41218 has been completed and the project is currently being closed; and WHEREAS, administrative efficacy and quality assurance require Mr. Bol to assist INDOT with the process of closing out T-41218; and

WHEREAS, Ryan Bol's employment negotiations with Michiana created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Ryan Bol is subject to the particular matter restriction under IC 4-2-6-11(a) and cannot assist future employers, including Michiana, with any matter he personally and substantially participated in while employed by INDOT.

NOW THEREFORE, Ryan Bol, a Construction Engineer, for his remaining tenure with the Department, or until he discontinues employment negotiations with Michiana Contracting, Inc., agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Ryan Bol must adhere to term four (4) regarding the particular matter restriction in perpetuity, for the life of each particular matter.

II. CONFLICT OF INTEREST SCREEN

- 1. Except for the limited purposes of assisting with the closeout of T-41218, Ryan Bol shall not participate in any decision or vote, or any matter related to such decision or vote, in which Michiana has a financial interest.
- 2. Ryan Bol shall not make any decision impacting Michiana's interests in T-41218 without the input, review, and approval of his supervisor and/or the assigned Area Engineer.
- 3. Ryan Bol should be screened from participating in any present or future contract or other matter involving Michiana, except as provided above with regard to T-41218.
- 4. Ryan Bol shall not assist any future employers, including Michiana, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which Michiana Contracting, Inc. has a financial interest. I understand that the first three (3) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with Michiana Contracting, Inc., whichever occurs first. I further understand that term four (4) concerning the particular matter restriction applies in perpetuity, for the life of the matter. I have shared and discussed this Conflict of Interest Screen and its requirements with my supervisor.
