CONFLICT OF INTEREST SCREEN FOR RUSS BRITTAIN January 19, 2021

I. RECITALS

WHEREAS, Russ Brittain is Road Review Manager for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Russ Brittain has accepted a position with Corradino LLC; and

WHEREAS, Corradino has a business relationship with INDOT, including ongoing contracts with the Department; and

WHEREAS, as Road Review Manager for INDOT, it is possible that Russ Brittain could be assigned to work with Corradino or to participate in matters involving the company as part of his regular duties; and

WHEREAS, Russ Brittain's employment negotiations with Corradino created a potential decisions and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Russ Brittain is subject to the particular matter restriction under IC 4-2-6-11(a) and cannot assist future employers, including Corradino, with any matter he personally and substantially participated in while employed by INDOT.

NOW THEREFORE, Russ Brittain, Road Review Manager for INDOT, for his remaining tenure with the Department, or until he discontinues employment negotiations with Corradino LLC, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Russ Brittain must adhere to term three (3) regarding the particular matter restriction in perpetuity, for the life of each particular matter.

II. CONFLICT OF INTEREST SCREEN

- 1. Russ Brittain shall not participate in any decision or vote, or any matter related to such decision or vote, in which Corradino has a financial interest.
- Russ Brittain should be screened from participating in any present or future contract or other matter involving Corradino.
- 3. Russ Brittain shall not assist any future employers, including Corradino, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which Corradino LLC has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with Corradino LLC, whichever occurs first. I further understand that term three (3) concerning the particular matter restrict applies in perpetuity, for the life of the matter.
