I. RECITALS

WHEREAS, Corie Brockway is a Construction Inspector for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Corie Brockway has accepted a position with Lochmueller Group, Inc. ("Lochmueller"); and WHEREAS, Lochmueller has a business relationship with INDOT, including ongoing contracts with the Department; and

WHEREAS, as Construction Inspector for INDOT, it is possible that Corie Brockway could participate in matters involving Lochmueller as part of her regular duties; and

WHEREAS, Corie Brockway's employment negotiations with Lochmueller created a potential decisions and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Corie Brockway could be in some instances subject to the particular matter restriction under IC 4-2-6-11(a) and cannot assist future employers, including Lochmueller, with any matter she personally and substantially participated in while employed by INDOT.

NOW THEREFORE, Corie Brockway, a Construction Inspector for INDOT, for her remaining tenure with the Department, or until she discontinues employment negotiations with Lochmueller Group, Inc., agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Corie Brockway must adhere to term three (3) regarding the particular matter restriction in perpetuity, for the life of each particular matter.

II. CONFLICT OF INTEREST SCREEN

- 1. Corie Brockway shall not participate in any decision or vote, or any matter related to such decision or vote, in which Lochmueller has a financial interest.
- 2. Corie Brockway should be screened from participating in any future contract or other matter involving Lochmueller, except those contracts on which she works with Lochmueller as a peer.
- 3. Corie Brockway shall not assist any future employers, including Lochmueller, with any matter she personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which Lochmueller Group, Inc. has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with Lochmueller Group, Inc., whichever occurs first. I further understand that term three (3) concerning the particular matter restrict applies in perpetuity, for the life of the matter.
