I. RECITALS

WHEREAS, Stephan Goldner is a Project Supervisor for the Indiana Department of Transportation ("INDOT" or "Department"); and

WHEREAS, Stephan Goldner has accepted a position with RQAW Corporation ("RQAW"); and WHEREAS, RQAW has a business relationship with INDOT, including ongoing contracts with the Department; and

WHEREAS, as a Project Supervisor for INDOT, it is possible that Stephan Goldner could be assigned to work with RQAW or to participate in matters involving the company as part of his regular duties; and

WHEREAS, Stephan Goldner's employment negotiations with RQAW created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Stephan Goldner is subject to the particular matter restriction under IC 4-2-6-1 l(a) and cannot assist future employers, including RQAW, with any matter he personally and substantially participated in while employed by INDOT.

NOW THEREFORE, Stephan Goldner, a Project Supervisor for INDOT, for his remaining tenure with the Department, or until he discontinues employment negotiations with RQAW Corporation, agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Stephan Goldner must adhere to term three (3) regarding the particular matter restriction **in** perpetuity, for the life of each particular matter.

II. CONFLICT OF INTEREST SCREEN

- 1. Stephan Goldner shall not participate in any decision or vote, or any matter related to such decision or vote, in which RQAW has a financial interest.
- 2. Stephan Goldner should be screened from participating in any present or future contract or other matter involving RQAW.
- 3. Stephan Goldner shall not assist any future employers, including RQAW, with any matter he personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.

III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict ofInterest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which RQAW Corporation has a financial interest.
