William ("Bill") Kreger is a Construction Supervisor for the Indiana Department of Transportation (INDOT)- Ft. Wayne District.
Mr. Kreger recently accepted a position with VS Engineering, Inc. VS Engineering has a business relationship with INDOT, including ongoing contracts with the Department. As such, Mr. Kreger's employment negotiations with VS Engineering created a potential decisions and voting conflict of interest under IC 4-2-6-9.
This disclosure is therefore being filed in anticipation of that potential conflict, although Mr. Kreger is not otherwise subject to the mandatory cooling off period under IC 4-2-6-11(b).

This disclosure was provided to Mr. Kreger's appointing authority, INDOT Commissioner Joe McGuinness, on April 22, 2019.

WHEREAS, William ("Bill") Kreger is a Construction Supervisor for the Ft. Wayne District of the Indiana Department of Transportation (INDOT); and

WHEREAS, Bill Kreger has recently entered employment negotiations with VS Engineering, Inc.; and

WHEREAS, VS Engineering has a business relationship with INDOT and active contracts with the Department; and


II. CONFLICT OF INTEREST SCREEN
