Describe the conflict of interest:
Ms. Mote is currently employed with a company known as Project Lead the Way ("PLTW"). PLTW is a non-profit organization headquartered in Indianapolis that provides science, technology, engineering, and math programs nationwide. PLTW creates programs that assist students to develop in-demand, transportable skills--such as problem solving, critical and creative thinking, collaboration, and communication. PLTW provides teachers with professional development and the continual support and resources they need to implement the program with fidelity to the engaging activity, project, and problem-based (APB) instructional design model.

IC 4-2-6-9 (Conflict of economic interest; commission advisory opinions; disclosure statement; written determination) states in relevant part:

(a) A state officer, an employee, or a special state appointee may not participate in any decision or vote, or matter relating to that decision or vote, if the state officer, employee, or special state appointee has knowledge that any of the following has a financial interest in the outcome of the matter:

(3) A business organization in which the state officer, employee, or special state appointee is serving as an officer, a director, a member, a trustee, a partner, or an employee.

During the November 6, 2019, Board meeting, an agenda item labeled "C. 2020-2021 Course Titles and Descriptions" was presented on the Board's consent agenda for a vote. The agenda item includes recommendations from the Indiana Dept of Education concerning course and title updates for the 2019-2020 school year. The recommendations included references to courses offered by PLTW. Due to Ms. Mote's affiliation with PLTW, when the Board reached the consent agenda, Ms. Mote recused herself from the vote regarding agenda item "C. 2020-2021 Course Titles and Descriptions."




