I am no longer on the Board of Directors, but when I served as CEO I helped select Teachers' current CEO. I currently serve as a Board Member Emeritus, for Teachers Credit Union, which is an honorary title with no ownership interest. My only current ownership interest in Teachers Credit Union is that of a member. All people who hold accounts at credit unions are considered members and hold ownership interests. My current ownership interest is not greater than any other regular member of Teachers Credit Union. Out of an abundance of caution, I am filing this Ethics Disclosure Statement prior to the vote involving Teachers Credit Union at the DFI Members Meeting on November 14, 2019.
