3. I will not attend any meeting of the JTRP or its executive board, or any meeting between INDOT & Purdue officials; and
4. Deputy Commissioner Gallagher and I will immediately notify INDOT's Ethics Officer, who will verify that I have had no interaction with Purdue, the JTRP, or INDOT's Research Division on any such matter.
