In the fourth count, the casino violated rules on playing cards. In the fifth count, the casino violated sensitive key rules. Tropicana agreed to a monetary settlement of \$19,000 in lieu of disciplinary action.

Action: Upon motion by Joseph Svetanoff, second by Marc Fine, and unanimous vote of those present, the Commission approved the settlement agreements by adopting Order 2019-46 through Order 2019-57.




