CHAIRMAN THOMPSON: Good afternoon. My name is Milt Thompson, and I am the chairman of the Indiana Gaming Commission, and I have the distinct pleasure of calling this meeting to order.

Mr. Small, how about a couple introductions and perhaps then a roll call.

EXECUTIVE DIRECTOR SMALL: Excellent. Well, you've already introduced yourself. everybody, we have a new face here up front. have a new chairman. I'd like to introduce Milton O. Thompson of Indianapolis. He's an attorney and of counsel at the law firm Bleeke Dillon Crandall. Mr. Thompson is president and CEO of sports entertainment and recreation management consulting firm, Grand Slam. Mr. Thompson has a history of civic and community involvement such as Play Ball Indiana, board member of the Indianapolis Indians baseball club, Big Brothers and Big Sisters of Indiana, Central Indiana Community Foundation, Indianapolis Foundation, Indiana University School of Law board visitors, Pan-American Games general counsel, Indiana Sports Corporation vice president, Indianapolis Capital Improvement

board, Tours and Tomorrow board Visit Indy,
Indianapolis Bond Bank, and Hoosier Lottery
commission.

Mr. Thompson currently serves on the English Foundation and is the vice chairman for the Crown Hill board of managers and foundation.

Mr. Thompson graduated from Wittenberg
University with a BA and from Indiana University
School of Law, Bloomington. Mr. Thompson was
appointed to the commission in April of 2022.

Anjelica has previously worked at the Indiana

Department of Child Services as a staff attorney,

the Office of the Indiana Attorney General as a

deputy attorney general, and most recently at

Pricewaterhouse Coopers logility and knowledgable

as a document review attorney. Welcome aboard.

Next if we could have Carmen Steven please stand up.

Carmen is the IGC's newest director of human resources for law enforcement executive administrator. Carmen has over a decade of experience in human resources, including seven years with the state of Indiana. The IGC recruited Carmen from the state personnel where she most recently served as human resources director for a number of agencies. Carmen holds a bachelor of science degree in human resource management from Kelley School of Business and a professional certification from the Society for Human Resource Management.

Our investigations division has completed reinvestigations for the following licensees:

House Advantage and American Gaming Systems, LLC.

The confident reports, Commissioners, are in your

materials. Directors Brown and Leek are also present should you have any addition questions.

The IGC has added 18 individuals to the statewide exclusion list since the March 8th, 2022, meeting. The total number of individuals on the list is now 933.

And, finally, the IGC has granted 14 waivers to Indiana casinos since the previous meeting.

This information is included in your materials and will be posted at the commission's website.

MR. DUDLEY: Good afternoon, Chairman,
Commissioners. You have before you Orders
2022-56 through 60 concerning the petitions for
removal for the exclusion list of Lloyd Weddle,
John Jablonski, Patricia Strickland, Wanda Adams,
and Trent Cobb. Petitioners have been placed in
the exclusion list for over three years and have
petitioned to be removed from the exclusion list.
Telephonic hearings were conducted at which each
provided support for their petitions.

Based on totality of the factors relevant in these matters, the reviewing officer has

concluded that Weddle, Jablonski, Strickland, and Adams have met the standard of clear and 2 convincing evidence as reflected in the staff's 4 findings of fact and recommendation. Adopting staff's findings and recommendations would have the effect of granting petitioners petitions for removal from the statewide exclusion list.

> Based on the totality of the factors relevant in these matters, however, the reviewing officer has concluded that Cobb has failed to meet the standard of clear and convincing evidence as reflected in staff's findings of fact and recommendation.

> Adopting staff's findings and recommendation would have the effect of denying Cobb's petition for removal from the exclusion list.

Before you have Order 2022-61 pursuant to Indiana Code Section 4-33-7-8 and 68 IAC Section 2-2-8. A supplier's license must be renewed each year along with the payment of \$7500 renewal fee.

Each of the following licensees has
submitted timely requests for renewal along with
the required payment: Surveillance System
Integration; Power Strategies, LLC; Bally's
Interactive, LLC; White Hat Gaming; Konami
Gaming, Incorporated; Masque Publishing,
Incorporated; Everi Payments, Incorporated;
Ainsworth Game Technology; United States Playing
Card Company; House Advantage, LLC; Novomatic
America Sales, LLC; NRT Technology Corporation;
Pala Interactive; VICI Properties, Incorporated;
Kambi; and Geocomply Solutions, Incorporated.

effect of renewing the license of each of the respective licensees for a period of one year. Thank you.

And for casino renewals.

Commissioners, next on the agenda you have Orders 2022-62, 2022-63, and 2022-64 regarding renewal of Ameristar, Hard Rock Northern Indiana, and Horseshoe Hammond Casino owner's license renewals respectively. Ameristar, Hard Rock Northern Indiana, and Horseshoe Hammond have all filed the proper paperwork and paid the renewal fee. Previously by Orders 2021-10, 2021-123, and 2021-73, the Commission had approved the written power of attorneys for Ameristar, Hard Rock Northern Indiana, and Horseshoe Hammond respectively. These approvals expire upon renew of the casino owner's license, and for that reason all casinos must request renewal of the Commission's approval of the written power of attorney concurrently with the request for renewal or present the Commission with a new power of attorney naming a new trustee.

Ameristar, Hard Rock Northern Indiana, and Horseshoe Hammond have all stated their intent to maintain their existing trustees in waiting and

have not presented the Commission with any modifications to their power of attorney.

Approving Orders 2022-62, 2022-63, and 2022-64 would have the effect of renewing the license and approving the power of attorneys for Ameristar, Hard Rock Northern Indiana, and Horseshoe Hammond for a period of one year. Thank you.

And then next you have before you Order 2022-65, pursuant to Indiana Code Section 4-38-6-6, a vendor's license must be renewed each year along with payment of a \$50,000 renewal fee. Each of the following licensees has submitted a timely request for removal along with the required payment. That would be Penn Sports Interactive and Digital Gaming Corporation doing business as Betway.

Approving Order 2022-65 would have the effect of renewing the license of each of the respective licensees for a period of one year. Again, thank you.

And next and finally, you have before you Order 2022-66, pursuant to Indiana Code Section 4-33-24-15, and 68 IAC Section 26-3-10, a Paid Fantasy Sports operator license must be renewed

each year along with a payment of a \$5,000 renewal fee. Each of the following certificate holders has submitted a timely request for renewal along with the required payment. That includes DraftKings, Incorporated, FantasyDraft, LLC, and FanDuel, Incorporated.

Approving Order 2022-66 would have the effect of renewing the license of the respective licensees for a period of one year.

CHAIRMAN THOMPSON: Thank you, Mr. Neal.

Danielle Leek, are you prepared to give permanent licenses and suppliers?

MS. LEEK: Good afternoon, Commissioners and executive staff. Order 2022-67 will approve the permanent supplier license for Acres Manufacturing. Acres Manufacturing designs, manufactures, sells, and supports hardware and software system that relate to player tracking and machine payouts. Acres Manufacturing and its key persons have submitted the required applications and received temporary licenses as issued by the IGC. Commission staff conducted a background and financial investigation on the company along with its substantial owners and key persons. We have found no material derogatory information that would affect suitability for the applicant. Staff's final report has been provided in the confidential commission meeting documents.

Approving Order 2022-67 will grant the permanent license to Acres Manufacturing subject to yearly annual renewal.

I'm happy to answer any questions that you may have.

Order 2022-72 is a settlement agreement with IGT totaling \$1,500.

Order 2022-73 is a settlement agreement with NRT Technology Corporation including three counts totaling \$4,000.

Order 2022-74 is a settlement agreement with Pala Interactive including two counts totaling \$2,500.

Order 2022-75 is a settlement agreement with Ameristar in Chicago including six counts totaling \$12,500.

Order 2022-76 is a settlement agreement with Bally's Evansville including six counts totaling \$13,000.

Order 2022-77 is a settlement agreement with Belterra Casino including three counts totaling \$8,500.

Order 2022-78 is a settlement agreement with

Blue Chip Casino including four counts totaling \$11,500.

Order 2022-79 is a settlement agreement with Caesars Southern Indiana including nine counts totaling \$87,000 and a corrective action plan.

Order 2022-80 is a settlement agreement with French Lick Resort Casino including five counts totaling \$19,000.

Order 2022-81 is a settlement agreement with Hard Rock Northern Indiana including four counts totaling \$47,500.

Order 2022-82 is a settlement agreement with Harrah's Hoosier Park including four counts totaling \$20,000.

Order 2022-83 is a settlement agreement with Hollywood Casino including four counts totaling \$24,000.

Order 2022-84 is a settlement agreement with Horseshoe Hammond including five counts totaling \$17,000.

Order 2022-85 is a settlement agreement with Horseshoe Indianapolis including eight counts totaling \$130,725 and a corrective action plan.

Order 2022-86 is a settlement agreement with Rising Star Casino including three counts

totaling \$12,000.

Order 2022-87 is a settlement agreement with Seminole Hard Rock International totaling \$4,000.

Order 2022-88 is a settlement agreement with Bally's Interactive doing business as Bally Bet totaling \$1,500.

Order 2022-89 is a settlement agreement with Digital Gaming Corporation doing business as Betway including three counts totaling \$6,000.

Order 2022-90 is a settlement agreement with American Wagering doing business as Caesars

Sportsbook including two counts totaling \$5,500.

Order 2022-91 is a settlement agreement with Churchill Downs Interactive Gaming doing business as Twinspires totaling \$3,500.

Order 2022-92 is a settlement agreement with Betfair Interactive doing business as FanDuel Sportsbook including three counts totaling \$6,000.

Order 2022-93 is a settlement agreement with Caesars Race and Sportsbook Clarksville totaling \$4,500.

DraftKings including two counts totaling \$2,000.

Order 2022-100 is a settlement agreement with WSI US doing business as WynnBET including three counts totaling \$6,500.

Relevant details for each settlement agreement have been provided in your meeting materials. Details on the settlement agreements will also be available on the commission's website following the meeting.

The applicants were all given an opportunity to withdraw their applications from consideration but they all failed to do so.

Detailed information regarding these orders is contained in your confidential commission materials, and approval the orders of 2022-101 through 2022-110 would have the effect of denying these applications.

And also before you you have Orders 2022-111 through 2022-123. And Orders 2022-111 through 123 concern settlement agreements between the commission staff and the occupational licensees.

In lieu of disciplinary action, commission staff offered each of these licensees a settlement agreement that would have been agreed to an unpaid voluntary relinquishment of their occupational license for a period of regularly scheduled working days with no vacation or other paid time off to be used.

Each of these licensees has agreed to the terms of the settlement agreements, and detailed information of each of these matters is contained in the confidential materials provided to you

guys. And so approving Orders 2022-111 through 123 2 would have the effect of ratifying these 3 4 settlement agreements with the occupational 5 licensees. 6 CHAIRMAN THOMPSON: Any questions for 7 Mr. Neal? The confidential details of the proposed financial transactions as well as the commission staff's analysis were provided to the Commissioners in the confidential materials.

In accordance with the procedures identified in Resolution 2017-109, the casino licensees were issued an internal approval for their proposed financial transactions. The internal approval contained the following conditions.

First, the terms articulated in the final financing documentation do not materially differ from the terms that were presented in the written approval.

Second, the terms of the final documentation do not violate IAC 4-33 or 4-35.
