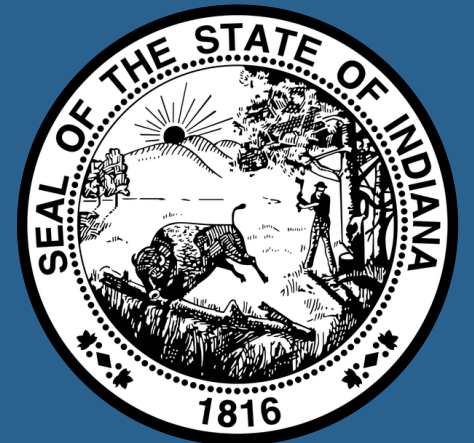

## Level 3

Personal Disclosure 3

**This is the highest level of licensure, and the application requires detailed information such as employment, family, litigation, and license history, as well as three years of bank statements, tax returns, and other financial documents.**

**Investigators use third-party sources to verify information such as employment verifications, IRS transcript requests, bank statement analysis, and online databases.**

**This investigation includes a personal interview with the applicant and a Final Report at completion.**

# Conducting Investigations

## Level 1

Personal Disclosure 1

**Investigators review of the applicant's previous work history, employment, license history, and criminal history.**

**Applicants are fingerprinted, must disclose full criminal history, and may not have a felony conviction.**

**Financial Investigators check the applicant's tax status with IDOR (if Indiana resident) or use Accurint to check for tax issues (if out of state).**

# Conducting Investigations

## Gaming Entity Investigations

LAM

**Detailed information is submitted by each Gaming Entity, depending on the type of company:**

- **Investigators analyze the company's background, formation, business in Indiana, gaming history, ownership, and financial status.**
- **Background Investigators compile company data, litigation history, and verify gaming licenses and potential violations with other jurisdictions.**
- **Financial Investigators analyze three years of financial statements and tax returns to provide financial picture of the entity.**
- **Investigators verify information with third-party investigative sources.**
- **A Final Report is completed for Gaming Entities and reviewed with Executive Staff prior to be added to a Commission meeting agenda for consideration of the Commission.**

LAM

**The system was launched in January 2022 and is planned to be fully completed by Summer 2024.**

**The Investigations Division took the lead on the creation and implementation of the IGC's new licensing system.**

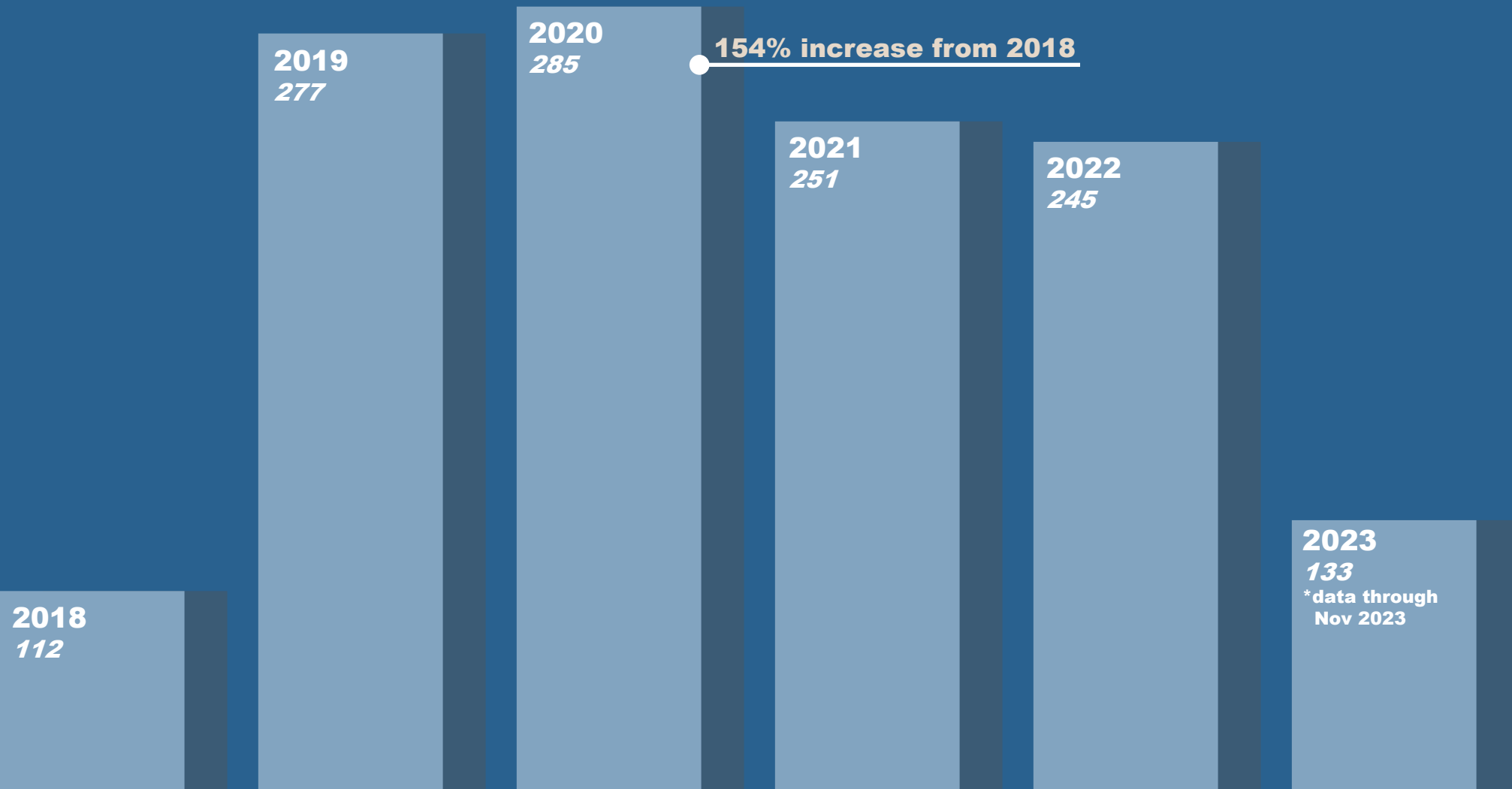
**LAM houses all Gaming Entity and Occupational Licensees.**

**LAM allows Gaming Entities access to the database to manage their licensees' information such as address changes, title changes, and yearly renewals.**
