HARD ROCK CASINO NORTHERN INDIANA Indiana Gaming Commission Property Update December 15, 2022



Background

- Effective July 1, 2019, Indiana House Bill #1015 amended the Indiana Gaming Code allowing the Gary riverboat to transfer to an inland location
- This amendment stipulated the eventual transition from Majestic Star's two gaming licenses into separate land-based entities
 - One license was designated for Gary, IN with the other designated for Vigo County
- The Gary license was converted into Hard Rock Casino Northern Indiana
 - The other license was awarded to Churchill Downs Inc to build a land-based entity in Terre Haute, IN (Vigo County)
- Ground-breaking for the Hard Rock Casino Northern Indiana was held in January 2020



Property Overview

Opened May 14, 2021

- \$300M Facility
- 212,000 Square Feet of Space (approximately 156,000 guest-facing square feet)

Gaming Floor

- Initially opened with ~1,200 Slot Machines, now at 1,718
- Initially opened with 80 Table Games, now at 76 (but more gaming positions)
- Retail Sportsbook Opened May 11, 2022
- Online Sportsbook Opened September 6, 2022

Amenities

- Five Restaurants
 - Hard Rock Cafe
 - Council Oak Steakhouse
 - Fresh Harvest Buffet
 - Constant Grind
 - Youyu Asian Dining
- Hard Rock Live Entertainment Venue (capacity 2,700)
- Plum Lounge VIP Lounge
- Rock Shop (Retail) and Unity Store (Luxury)































Financial Comparison – Hard Rock vs Majestic Star

Compared Revenue for Hard Rock Casino and Majestic over a 12-month period

- For Majestic, the period of March 2019 thru February 2020 was chosen to mitigate and exclude impacts of Covid closures
- Hard Rock revenues were compared for the time period of December 2021 thru November 2022 (last 12 reported months)
- Under this comparison, Hard Rock Casino has generated over \$270M additional gaming revenue than Majestic Star (growth rate of 184%)
- It has also led to an additional \$89.3M in taxes paid
 - Over 4x the amount paid under Majestic Star

 The Majestic Star vessels were sold in November 2021 and the land and buildings were sold in October 2022 - thus completing a full divestiture of remaining Majestic Star assets



Capital Improvements

Since opening, Hard Rock Casino has spent over \$7.2M in capital improvements

Significant projects include

- Partial conversion of Fresh Harvest buffet into additional slot gaming area
 - Added over 1,200 square feet of gaming and 65 slot machines
- Improvements to Hard Rock Live infrastructure
 - Includes addition of 36' x 19' Video Wall
- Addition of a satellite cage window in our Baccarat room










Team Member Demographics



Total Team Members: 1,478

- Local population drives our workforce
 - 29% of our team members reside in Gary
 - 85% of our team members reside in Indiana
- Focus on Retention
 - Over 600 team members initially transferred over from Majestic Star
 - Over 71% are currently a part of the Hard Rock Team



2022 Wage Adjustments


In 2022, Hard Rock increased wages for the majority of hourly team members across several positions including the following
