

RESOLUTION 1995- 5

A RESOLUTION CONCERNING THE REQUEST
OF PAR-A-DICE GAMING CORPORATION TO WITHDRAW FROM THE SWISS
PAR-A-DICE, L.P. APPLICATION FOR A RIVERBOAT OWNER'S LICENSE
AND

THE REQUEST THAT THE SWISS PAR-A-DICE, L.P. APPLICATION
NOT BE CONSIDERED IN THE INITIAL ROUND OF HEARINGS INVOLVING
SWITZERLAND COUNTY, BUT RATHER, IN ANY SECOND
OR SUBSEQUENT ROUNDS INVOLVING SWITZERLAND COUNTY

WHEREAS, the Indiana Gaming Commission, ("the Commission")
has the power and duty under IC 4-33-4-1 to fully and
effectively execute IC 4-33 ("the Riverboat Gambling Law");

WHEREAS, the Commission has the power and duty to take any
reasonable or appropriate action to enforce the Riverboat
Gambling Law;

WHEREAS, the Commission is required under IC 4-33-4-5 to
adopt standards for the licensing of persons regulated under the
Riverboat Gambling Law;

WHEREAS, pursuant to IC 4-33-4-17, the Commission is to
"decide promptly and in reasonable order all license
applications"; and

WHEREAS, on February 22, 1995, the Commission received a
written request from Par-A-Dice Gaming Corporation to withdraw
from the Swiss Par-A-Dice, L.P., application for a Indiana
Riverboat Owner's License to have a home dock site in
Switzerland County, Indiana (copy of letter attached).

WHEREAS, on March 10, 1995, the Commission received a letter
from Priority Investors, L.L.C. requesting that the Swiss Par-A-
Dice, L.P. application for an Indiana Riverboat Owner's License
not be considered during the first round of hearings scheduled
for Switzerland County but rather remain on file for
consideration at any second or subsequent hearings involving
applicants for Switzerland County and bearing responsibility for
any additional cost which such actions may incur (copy of letter
attached).

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING
COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

SECTION 1. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC 1-1 apply
to this resolution.

SECTION 2. REQUEST TO WITHDRAW.

The Request of Par-A-Dice Gaming Corporation to withdraw from the Swiss Par-A-Dice, L.P., application for Indiana Riverboat Owner's License, received on February 22, 1995, is hereby

The request of Priority Investors, L.L.C., that the application of Swiss Par-A-Dice, L.P. not be considered during the first round of hearings scheduled for Switzerland County but rather remain on file for consideration at any second or subsequent hearings involving applicants for Switzerland County, including responsibility for any additional cost which such actions may incur, is
