

## **RESOLUTION 2001-28**

### **A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIERS' LICENSES**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. On March 30, 2000, by RESOLUTION 2000-10, a permanent supplier's license was issued to Bally Gaming, Inc.
2. On August 21, 2000, by RESOLUTION 2000-28, renewal of suppliers' licenses was issued to GEMACO Playing Card Company, Mikohn Gaming Corporation, Osborne Coinage Company, Paul-Son Gaming Supplies, Inc., Atronic Americas, LLC, Kilmartin Industries, Inc. d/b/a-Roger Williams Mint, V.S.R. Lock, Inc. and Riverboat Services, Inc.
3. On September 18, 2000, by RESOLUTION 2000-33, permanent suppliers' licenses were issued to Spin for Cash Wide Area Progressive joint Venture and Hornblower Marine Services.
4. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a supplier's license must be renewed annually.
5. The above-named supplier licensees have requested a renewal of licensure and have provided payment of the renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8.
6. The Commission has determined that the above-named supplier licensees remain in compliance with IC 4-33.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

#### **SECTION 1. SCOPE.**

This resolution applies to all supplier licensees listed above in paragraph one, two and three.

#### **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3. GRANT OF RENEWAL OF SUPPLIERS' LICENSES.**

The Commission hereby grants the renewal of the suppliers' licenses issued to the suppliers listed below. The renewed suppliers' licenses will be valid for a period of one (1) year from the date of issuance.

**SECTION 4. CONDITIONS PLACED ON SUPPLIER'S LICENSE.**


- A. Each supplier licensee must request renewal of licensure at least thirty (30) days before the expiration of the license in accordance with 68 IAC 2-2-8.
